DSBN 2025 Summer eLearning for Students Currently in Grades 9-12

Eligibility:

- Summer eLearning credit courses are for:
 - o current DSBN students finishing grade 9 or higher including current DSBN fee-payer students
 - Students pre-reg for Grades 10-12 at a DSBN high school for September and coming from out-ofboard

Dates and Course Delivery:

- eLearning dates are July 2-30, 2025, including summer school COOP (1 or 2 credit.)
- All courses are run as asynchronous eLearning courses only. Guidance teams have the course list.
- Students can only register for one (1) summer school course.
- Teachers must be online and available each day from 8:30 a.m. 2:00 p.m. and have 4 hours of synchronous office hours available daily.

Summer School COOP

- All students interested in summer school COOP <u>must</u> have their own job/employment
- COOP is only available to students who meet the eligibility above and are going into grade 11 or 12

Registration Process for eLearning Courses

- **Current DSBN high school students** are to register for summer school eLearning through their DSBN high school guidance department before noon on Friday, May 23, 2025.
- Out-of-board students who are pre-reg with a DSBN high school for grades 10-12 must also register with the DSBN high school's guidance department. This ensures that these students are, indeed, fully registered to attend a DSBN high school in Sept. for grades 10-12.
- For any current DSBN high school fee-paying students interested in taking a summer school course:
 - 1) Please pay your course fee through the DSBN Welcome Centre.
 - 2) Once schools receive a "Letter of Acceptance" (LOA) from the Welcome Centre, your guidance team will meet with the student to register for a summer school course.

Registration for Summer School COOP

- Eligible students going into grades 11 or 12 are to:
 - → register with their DSBN high school guidance department,
 - → **AND** bring the following employment information. Guidance teachers will have the link to the summer school coop form to enter this info.
 - Name and address of employer
 - Name, telephone number and email address of supervisor
 - Start date with this employer
 - Approximate # of hours per week

Important information to consider when deciding to take a summer eLearning course:

- Summer school's compressed timeline means there is a 6-hour time commitment per day to achieve the Ministry's hours of instruction.
- If considering travelling abroad during the course:
 - o This would present a challenge for students to meet this time requirement
 - o The family would be responsible:
 - to set up an MFA (Multi-Factor Authentication) **before** leaving the country in order to be able to access any DSBN eLearning materials. Instructions would be provided.

- to ensure that their destination country would not have any restrictions on accessing certain platforms used for eLearning like Google or YouTube, for example.
- to be aware that if a student is out of country, the DSBN I.T. team will not be able to support families with any technical issues that may arise.
